Admission to the School is granted by the School Governors according to the published admissions criteria, which are also at the end of this supplementary information form.

Please note that completion of this form does not guarantee a place at the School and this application will be void if false information is given. We may ask for further evidence to support your application. This form should be returned to the School from 01 September 2021 and before the deadline of 15th January 2022. If you are applying under the Emmanuel Church membership criterion this form should be submitted directly to Fr Jonathan in good time so that applications can be cross-checked against the Church attendance register and then the form will be forwarded by him to the school office.

This Supplementary Information Form, signed by the clergy person in charge of your Church, supporting your application and confirming that the criterion under which you are applying is satisfied, is required if you are applying under any of criteria A1, A2, A3, A4 or A5. Additionally, if you are applying under criterion A4, this Supplementary Information Form signed by the clergy person in charge of your *former* Church supporting your application and confirming that the criterion is satisfied, is also required. **Applications without the relevant signed form(s) will only be considered after all other applications under this criterion.**

Children of parent(s) who currently attend Emmanuel Church, West Hampstead with the regularity of a Member having moved into their home^{iv} in the London Borough of Camden (or a Borough which shares a border with Camden) within the twenty-four month period immediately preceding the date of this application, and for at least the twelve month period immediately preceding the date of their move have been members of another Christian Church^v.

A5. Children whose parent(s) are current membersⁱⁱ of another Christian Church^v.

In the event of all the places not being filled under Route A, the remaining number of places shall be added to the Route B Community Criterion.

ⁱ "Parent" means a person having legal parental responsibility for the child or who is the legal guardian of the child.

ⁱⁱ "Member" of Emmanuel Church or another Christian Church ^v means regular attendance by the child together with at least one Parent at that church, and regular attendance shall mean attendance for a minimum of six services in each of the eight successive quarters in the twenty four month period immediately preceding the date of the application as evidenced in the Church attendance register signed at the end of each service.

ⁱⁱⁱ "Sibling" means a brother or sister, an adopted brother or sister, a step brother or sister, or a child of the Parent's partner, where, in each case, the child for whom the school place is sought has her or his Home within the same Family unit at the same address as the sibling. The sibling should be currently attending the Main School or previously attended the Main School.

^{iv} "Main School" means from reception to year 6

^v "Christian Church" means a church belonging to Churches Together in Britain and Ireland or a member church of the Evangelical Alliance.

^{vi} "Home" means the child's principal place of residence with her or his Family unit at the time of the application closing date. Where the child for whom the school place is sought ordinarily lives with each Parent separately each week, then the child's principal place of residence is where the child lives for the majority of each week. We will not accept a temporary address if you still have a property that was previously used as a home address, nor will we accept a temporary address used solely or mainly to obtain a school place. You may be asked to supply additional information to explain why you are not able to use your permanent address.
